

SUMMARY ANNUAL REPORT

For VINCIT GROUP & MEMBER COMPANIES EMPLOYEE BENEFITS PLAN

This is a summary of the annual report of the VINCIT GROUP & MEMBER COMPANIES EMPLOYEE BENEFITS PLAN, EIN 62-1723130, Plan No. 501, for period 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

VINCIT GROUP & MEMBER COMPANIES has committed itself to pay certain self-insured Medical claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with UNUM LIFE INSURANCE COMPANY OF AMERICA, SYMETRA LIFE INSURANCE COMPANY, STANDARD INSURANCE COMPANY and LIFE INSURANCE COMPANY OF NORTH AMERICA to pay Medical, Dental, Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Critical Illness and Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$1,185,692.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2023, the premiums paid under such "experience-rated" contracts were \$472,615 and the total of all benefit claims paid under these contracts during the plan year was \$358,310.
